(See below)** All spaces are 10'x 10' (outside) for \$75.00 per space, per day. Please specify number of spaces needed on application below, which includes 1 eight-foot table and two chairs only. Crafters must supply their own tents.

**Jewelry Vendors: Jewelry Vendors will be limited and juried. All applications must be in by June 30, 2010. Acceptance letters will be mailed by July 15, 2010. Applications for Jewelry Vendors must include photos.**

The exhibitor presents to Plymouth Festival Committee that it maintains a liability insurance policy sufficient to provide for, and meet the responsibilities of, any of the exhibitor's liability undertakings under agreement. Assigned space is not transferable; all exhibits must be in place one half hour before open, and ready to sell.
